You will remain in "pending" status until you have received your ND Registration Number from the BDDT-N. While a "pending" member, you will receive all the full benefits of Professional Membership (discounted registration rates for CE events, including the Fall Convention; access to the MAP program, OAND business programs/services, members-only website, Discussions Group, etc.) with the exception of referrals and public representation as an ND (i.e. you will not be included in the OAND referral system until you are a registered ND, nor may you represent the profession on behalf of the OAND, such as public speaking or writing articles, until you are a registered ND). Because OAND professional membership is limited to registered NDs, your membership may be suspended if you have no plans to become registered by Spring of 2012.

You agree to contact us as soon as you receive your ND Registration Number from the BDDT-N so that we may enter that number into our system; at that time, your status will change from "pending" to "Professional Member" (Active 1<sup>st</sup> Year Practitioner category) and you will then be entitled to full benefits of membership (including referrals and representing the profession as an ND).
